A. Application Deadline

Applications must be submitted electronically to CPB at: csg@cpb.org, no later than 5:00pm ET on June 30, 2020 and include a copy of the fully executed consolidation agreement.

B. Spending Period

The spending period for an OEM grant is the same as the spending period in the related Television Community Service Grant General Provisions and Eligibility Criteria (“General Provisions”). The General Provisions and other agreements governing the OEM grant are available at: cpb.org/stations/.

C. Licensee Official and Head of Grantee

This application must be executed by the licensee official and the head of grantee. The licensee official for community licensees is the licensee’s governing body chair or vice chair; for other licensees, it is the licensee’s governing body chair or vice chair, or a designated senior level representative, who is not a member of the station’s management and who has the authority to enter into binding contracts on the licensee’s behalf (Licensee Official). The head of grantee is the highest-ranking representative of the station’s management responsible for station operations, such as its president and chief executive officer (Head of Grantee).

D. False Claims Act & CSG Non-compliance Policy

By executing this application, the Licensee Official and Head of Grantee recognize that by providing false information to obtain the OEM or any other grant from CPB may subject Grantee to penalties under the Federal False Claims Act, 31 U.S.C. §§33729-3733 and CPB’s CSG Non-compliance Policy.
